**AN ORDINANCE AMENDING SECTION 111.50 (A) (2) (k) OF THE OAK FOREST MUNICIPAL CODE REGARDING LIQUOR LICENSE CLASSIFICATIONS AND FEES**

WHEREAS, the City of Oak Forest is an Illinois municipal corporation organized and operated under the laws of the State of Illinois; and

WHEREAS, the City of Oak Forest is a home rule municipality as defined by Article VII of the Illinois Constitution; and

WHEREAS, the City desires to amend such sections of the Municipal Code as it relates to Liquor License Classifications and Fees.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OAK FOREST, COOK COUNTY, ILLINOIS, as follows:

**SECTION 1:** The foregoing recitals are incorporated as substantive portions hereof as though fully set forth herein.

**SECTION 2:** That Section 111.50 (A) (2) (k) be deleted in its entirety and replaced in lieu thereof with the following:


(k) – It shall be unlawful to sell, offer, give away or permit to be sold, offered, or given away, at retail, in or upon a Class B licensed beer garden, any alcoholic liquor between the hours of 2:00 a.m. and 11:00 a.m. Sunday through Thursday, nor between the hours of 3:00 a.m. and 11:00 a.m. on Fridays and Saturdays.

**SECTION 3:** All Ordinances in conflict herewith are hereby repealed to the extent of such conflict.


**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage, approval and publication, as provided by law.
