**AN ORDINANCE AMENDING CHAPTER 32 – CITY ORGANIZATIONS AND PROGRAMS – POLICE DEPARTMENT (ADDITION TO THE MUNICIPAL CODE FOR A BAIL/BOND FEE).**

**WHEREAS, the City of Oak Forest is an Illinois municipal corporation organized and operated under the laws of the State of Illinois; and**

**WHEREAS, the City of Oak Forest is a home rule municipality as defined by Article VII of the Illinois Constitution; and**

**WHEREAS, the City desires to amend such sections of the Municipal Code as it relates to the Police Department specifically for the purpose of the addition of a Bail/Bond Fee.**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OAK FOREST, COOK COUNTY, ILLINOIS, as follows:**

**SECTION 1:** The foregoing recitals are incorporated as substantive portions hereof as though fully set forth herein.

**SECTION 2:** That a new Section 32.061 - Fee for Bail/Bond Administration is added as follows:

*The Police Department will charge an administrative fee of fifty dollars (\$50.00) for the processing of bail or bond of an individual in any legal process, civil or criminal, or on any bookable arrest, including any arrest on a warrant. Any fee not paid within 30 days of posting bail or bond, shall be subject to a fee of two hundred dollars (\$200.00).*

**SECTION 3:** All Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage, approval and publication, as provided by law.
